It also appeared that St Francis Church was also interested in a venture of this nature and as a result Councillor Mrs Tilling was trying to coordinate both parties.

19 Borough and County Member Reports

Councillor Mrs Tilling was the lead member on environment issues on the TVBC Overview and Scrutiny Committee. Last October she had commissioned a review on the publicity material for recycling. This had resulted in a promotional recycling campaign in Andover. As a result of its success this would now be an ongoing campaign throughout the year with events being held at the Romsey Carnival and other venues. The aim of the campaign was of course to increase the recycling rate for TVBC.

Councillor Mrs Tilling also reported upon the ongoing parking issues in Valley Park. Councillor Mrs Tilling, Sargent O'Hanlon together with two senior managers form Aviva had visited the area early in the morning to ascertain which staff were parking in the local area. Aviva were very committed to getting their staff to park responsibly and not impact upon local residents. They had a park and ride scheme as well as a series of incentives in order to encourage people to car share or cycle. The problem was that many of the new employees did not register their cars so the company struggled to ascertain who the culprits
