### 33 Borough and County Member Reports

Councillor Mrs Tilling reported that the Great Covert application was going to the Test Valley Borough Council Southern Area Planning Committee the following evening for determination with a recommendation for Refusal.

Councillor Mrs Tilling also reported that the TVBC Overview and Scrutiny Committee review on community safety was still outstanding. There had now been a change in the lead member for this review and Councillor Mrs Tilling would now try and accelerate this issue.

Councillor Dowden reported upon a letter he had received from Chief Inspector Thorne, the Test Valley Divisional Commander regarding the changes he was having to make due to the recent budget reductions. For Valley Park this meant that PCSOs would now lead on community engagement matters leaving the remaining police officers to focus on enforcement. PCSOs would work with the community to identify who was responsible for local crime and anti social behaviour. The police officers would then follow this up.
