However, the Commission had notified, that as a result of consultation responses received to its draft recommendations, a further period of consultation on the Havant and New Forest district areas only, would commence on Tuesday 10 May for a four-week period.

This meant that the original timetable would be amended to take account of this development and it was anticipated that the Commission would notify Hampshire County Council, of their final recommendations, in early July.
