

**Minutes of the proceedings of Valley Park Parish Council held on Monday

100 Apologies for Absence

Apologies for absence were received from Councillors C Anderson Mrs. C. Dowden and Mrs. K. Tilling.

The Chairman reported Councillor Mrs Tilling had written to him requesting leave of absence due to her personal circumstances for a period of six months. The Clerk advised that Section 85 of the Local Government Act 1972 stated that if a member of a local authority failed throughout a period of six consecutive months from the date of his/her last attendance any meeting of the authority, he/she shall, unless the failure was due to some good reason approved by the authority before the expiry of that period, cease to be a Member of the authority. It was therefore necessary for the Council to approve her reasons for non-attendance.

both local primary Schools had been invited to attend to help with the planting of around 3,000 spring bulbs.
