Legislation We Work With

The Clean Neighbourhoods & Environment Act 2005

Allows for Dog Control Orders for

- Fouling of land by dogs and removal of faeces
- The keeping of dogs on leads
- The exclusion of dogs from land
- The number of dogs which a person may take onto any land



Dog Control Orders - CNEA

- Have to be with permission of land owner
- Are a legal process only after extensive consultation
- Have to have signs in place to indicate DCO
- Can be subject, if offence witnessed, to a fixed penalty charge or action in Magistrates Court

TVBC have *only* adopted the 'fouling of land by dogs and removal of faeces' DCO



The Environmental Protection Act 1990

Stray Dog Provisions

 Noise Complaints – typically barking but sometimes other animals/birds

The Animal Welfare Act 2006

• The "5 Freedoms" of animal care

May carry out initial investigation

Pass cases onto the RSPCA



Can work alongside the animal licensing legislation

How Do We Work

Our Aim – to seek & provide an amicable resolution to any problem in our field so that Test Valley remains an enjoyable place for everyone

We are

- Primarily reactive in response to a residents comment or complaint
- May involve calling at a property
- Detailed conversations on the phone
- The offering of advice
- Referrals to other experts



Numbers


In a typical year we would receive and respond to the following:

- Stray dogs: 180
- Barking Complaints: 167
- Reports/Complaints of Dog Fouling: 173
- Other Animal Related Complaints (including aggressive dogs and assisting the Police): 78
- Up to 100 animal licensing visits

And that's the main statutory work......
